_____ **After 90-day period**, \$150.00 per month continuation fee will apply and is billed in arrears. Failure to pay the continuation fee will result in a deactivation of the unit until all fees are paid. During this "storage" term, the unit will be removed from any and all advertising venues and will not be considered for sale. A \$250.00 per month storage fee will be charged until unit is reactivated.

_____ Motor Home Specialist will receive a commission of **8% of the selling price with a minimum of \$5,000.**

_____ Motor Home Specialist will be responsible for all advertising expenses on the following: Internet websites including MHSRV.com

_____ Consignee will be restricted from advertising the unit, by any means, for the duration of this exclusive contract.

_____ Exterior and/or interior detail is available for additional fees as selected in section 3 and are payable in advance.

_____ Motor Home Specialist is not responsible for any personal items that may have been left in the vehicle, is not responsible and will be held harmless for any theft or damage that may occur to said vehicle while on consignment. Please do not leave personal property in the vehicle while on consignment.

_____ I further certify that above-described RV has been delivered on consignment to Motor Home Specialist and that said dealership is acting on my authority, solely as a broker, when offering such vehicle for sale at their location.

_____ Vehicle owner agrees to keep full coverage insurance in effect while vehicle is in the care of Motor Home Specialist.

_____ Customer agrees to have a full tank of fuel, one-half tank of propane and have all holding tanks dumped before leaving RV with Motor Home Specialist; \$175.00 tank dump fee will apply and will be payable at time of consignment.

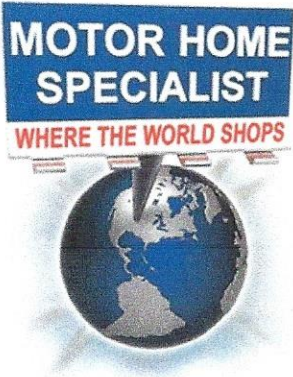
